"If you are not satisfied with a decision made by the Traffic & Parking Commission, you may appeal the decision by filing for a writ of certiorari with the Davidson County Chancery or Circuit Court. Your appeal must be filed within 60 days of the date of the entry of the Commission's decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met."

"Per the Tennessee Open Meetings Act, Public Chapter No. 300, members of the public are invited to provide comment on matters germane to the items on the agenda."

Director Alarcon provided additional information and examples of where and how we are working with other agencies to make improvements around the city.

- Lindsay Taylor and Derek Hagerty with NDOT provided an update to the commission and asked that they approve the proposed ordinance be submitted to council for review. Commissioner Woods recommended that this be sent to council for approval. Commissioner Green seconded the motion. The motion has been approved with no objections.

- Andrew Smith with NDOT provided background surrounding the request and discussion was had regarding the request. Director Alarcon provided additional clarification. Commissioner Green moved to approve. Commissioner Santos seconded the motion. The motion was approved with no objections.
- 6.4 CD 17: Authorization for 2-hour limited parking for four parking spaces on the south side of South St, effective 24/7 east of 12th Ave S, requested by Kimley-Horn on behalf of the Rochelle Center.
- Andrew Smith with NDOT provided background and discussions were had surrounding this request. Director Alarcon provided additional clarification. Commissioner Green moved to approve. Commissioner Woods seconded the motion. The motion was approved with no objections.
- 6.5 CD 19: Removal of designated Register of Deeds Parking 30-minute time limit and replacement with new 24/7 Pay Parking for approximately 8 spaces on the east side of 6th Ave S between Broadway and McGavock St, requested by NDOT.
- Director Alarcon with NDOT, Karen Johnson with the Register of Deeds, and Attorney Jack Brown spoke to this request. With the Register of Deeds moving to a new location they are requesting parking for customers at the new location. Commissioner Woods moved to approve. Commissioner Green seconded the motion. The motion was approved with no objections.

- On the north side of Deadrick St between 3rd Ave N and 4th Ave N, and
 - On the south side of Dr MLK Jr between 3rd Ave N approximately 100 ft west of 3rd Ave N, requested by NDOT.
 - Director Alarcon with NDOT, Karen Johnson with the Register of Deeds, and Attorney Jack Brown spoke to this request. With the Register of Deeds moving to a new location they no longer need these parking spaces they can become public parking. Discussion was had surrounding the request. Commissioner Green moved to approve. Council Member Evans-Segall seconded the motion. The motion was approved with no objections.

The commission would like to see clarification to Attachment A, identify where the CBD is and isn't (re-name the map). The commission would also like the application parameters outlined for permitting and removal of Attachment B. Jake Marshall PMC would like to request that the policy is posted in advance of the meeting. Council Member Evans-Segall moved to defer one month. Commissioner Woods seconded the motion. The motion was deferred for one month with no objections.

7.2 CD 19: Authorization for 50-ft Valet Zone on the west side of 12th Ave N at Grundy St, effective 11AM to 2PM and 6PM to 12AM /7 days, requested by Parking Management.

- Emanuel Matyas and Marcus Jackson from NDOT provided background surrounding the request. Jake Varshall with PNC spoke to request, and provided additional insight to the route and parking garage that is used. Discussions were had surrounding the request and how a new application could happen. Commissioner Green motioned to approve. Council Member Evans-Segall seconded the motion. The motion was approved with Neil Kornutick going on record as objecting.

Traffic and Parking Commission Authority
Chapter 9 of the Metropolitan Charter, Sec. 11.904. - Function of commission as to traffic regulation.

For the purpose of making the roads, streets and other public ways safe for pedestrians, motorists and others, and for the purpose of facilitating the flow of traffic thereon, the commission is hereby authorized to adopt and publish traffic regulations, including the erection of proper signs necessarily and properly connected with or incident to the following:

(a)The location and time when parking shall be limited.(b)Places where parking shall be prohibited entirely or only during certain hours.(c)The establishment of stop sign controls for through streets or isolated intersections.(d)The establishment of traffic signal controls.(e)The direction in which traffic may use any street or portion of a street.(f)Restrictions on the size of vehicles using certain streets.(g)The establishment of speed zones upon metropolitan streets and roads based upon the findings of the commission. When such zones are properly signposted, the speed indicated on the signs shall be the legal speed limit.

Such traffic regulations adopted by the commission shall take effect five (5) days after they have been published in a daily newspaper of general circulation within the area of the metropolitan government and after a certified copy thereof has been filed with the metropolitan clerk and the chief of police. Such regulations, when so adopted, shall have the force and effect of an ordinance, and shall be enforced by the metropolitan police. The metropolitan council shall provide by ordinance for the punishment of violators of such traffic regulations and shall fix proper and adequate fines and penalties.
