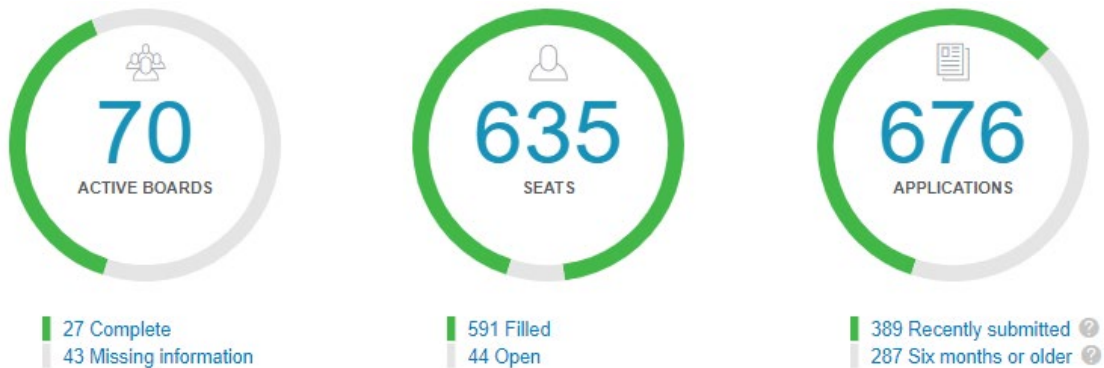


Boards and Commissions Graphs (ADA Compliant Script)

Graph 1

Presents information about board membership. There are currently 70 active board members, with complete information available for 27 boards and incomplete information for 43 boards. Among the 635 total board seats, 591 are occupied while 44 are unoccupied. Furthermore, there are 676 pending membership applications, with 389 recently submitted and 287 submitted more than six months ago.



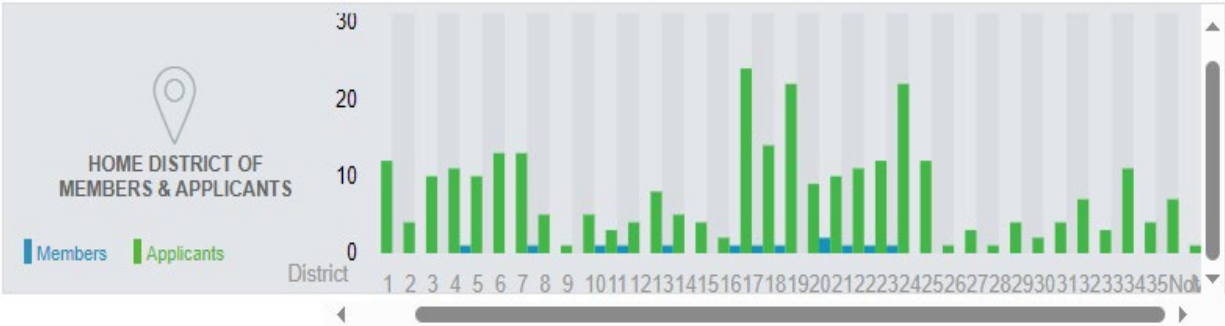
Graph 2

Represents the trend of term expirations over the course of the past year, with the highest number of terms expiring in April and the lowest number in December.

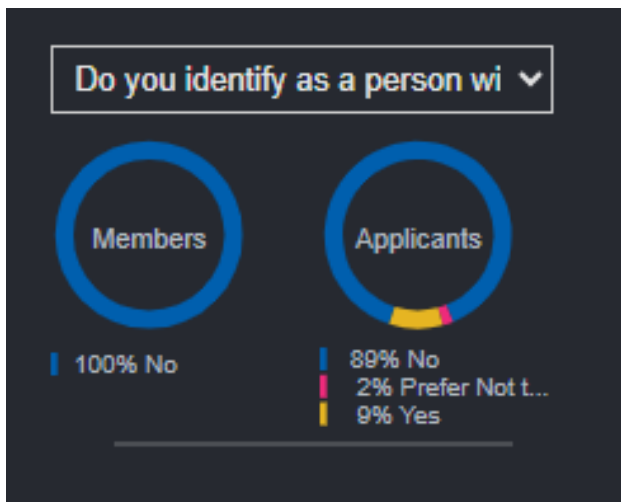

Illustrates the distribution of members and applicants across different districts, identified by their respective district numbers. However, it does not provide information regarding the number of applicants in each district. Please refer to Graph 7 for percentage value.

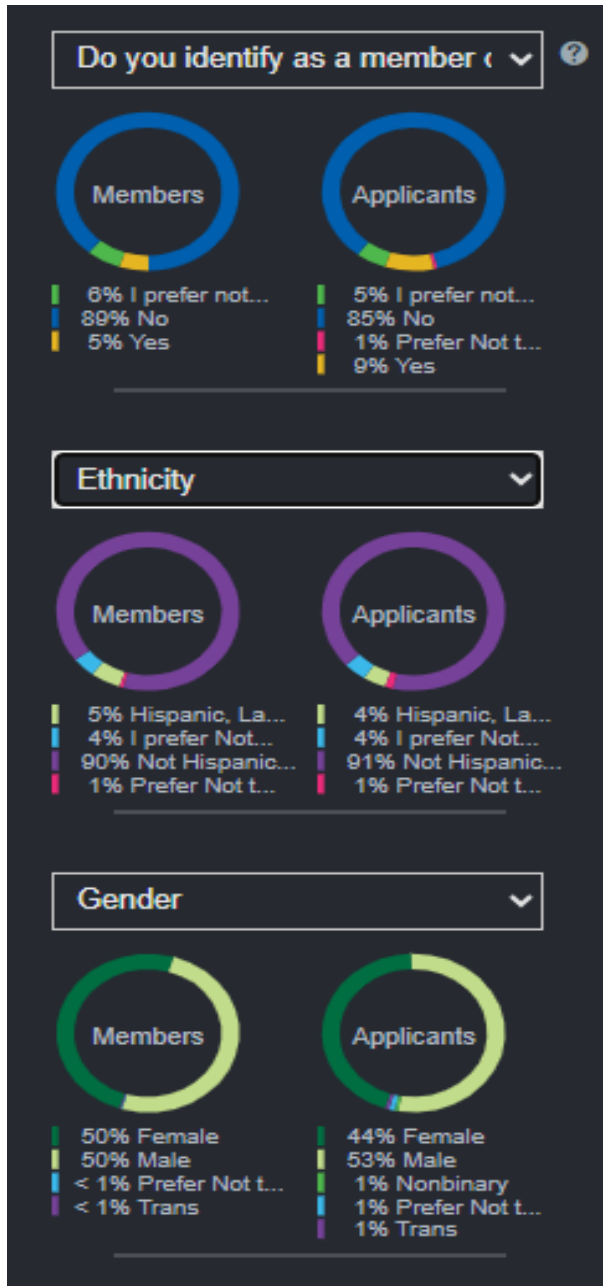


Graph 4



Provides information regarding individuals who are either members or applicants and self-identify as having a disability. For members 100% answered no. For applicants 89% answered no, 9% answered yes, and 2% prefer not to say.

Graph 5



Presents data on LGBTQ+. For Members 6% prefer not to say, 89% do not wish to identify as LGBTQ+, and 5% openly identify as LGBTQ+. For Applicants 6% prefer not to say, 85% do not wish to identify as LGBTQ+, and 9% openly identify as LGBTQ+.

Data on Ethnicity show among members, 5% identify as Hispanic, Latino, or of Spanish origin, 5% prefer not to say, and 90% do not identify as Hispanic, Latino, or of Spanish origin. For applicants, 4% identify as Hispanic, Latino, or of Spanish origin, 5% prefer not to say, and 91% do not identify as Hispanic, Latino, or of Spanish origin.

Data on Gender status show among members 50% identify as female and 50% identify as male, < 1% prefer not to say, and < 1% identify as Transgender. For applicants, 44% identify as female, 53% identify as male, 1% identify as nonbinary, 1% prefer not to say, and 1% identify as transgender.

Presents data on years of service on the Metro Boards and Commission. For members 21% served 1-2 years, 18% 2-3 years, 9% 3-4 years, 11% 4-5 years, 41% 5+ years. For applicants 28% served 1-2 years, 10% 2-3 years, 18% 3-4 years, 5% 4-5 years, 39% 5+ years.

Presents data on Race Group. For members 1% American Indian, 3% Asian, 32% Black or African American, 5% Hispanic or Latino, < 1% Native Hawaiian or Pacific Islander, <1% Other, 59% White. For applicants 3% Asian, 25% Black or African American, 3% Hispanic or Latino, < 1% American Indian, 1% Other, 67% White.

Illustrates the distribution of members and applicants across various districts of residence.
