HUD Local CoC Competition Addendum

These questions were submitted by community members in response to the CoC Local Competition application, which went live on June 27, 2024. Both the new and renewal applications are due on July 25, 2024.

Is there a match required for CoC funding? If so, what percentage of the award amount is required as a match?

Yes. HUD requires a 25% match of all projects.

If we have HUD funds from two years ago (2022) that we are still expending, and we did not apply for CoC funding last year (2023), should we submit a new or renewal application?

If you did not receive funding through the last round of the CoC competition (in 2023), you should complete a new application for your project. Please note that this only applies for CoC funding. *Please note: other types of HUD funding – such as the Emergency Solutions Grant (ESG), Housing Opportunities for Persons With AIDS (HOPWA), Community Development Block Grant Program (CDBG), and any other type of funding provided by HUD – has no bearing on the CoC competition and would not affect whether you would submit a new or renewal application.*

Has an RFP document been released outside of the application on Zoom Grants?

No, there is no RFP document because HUD has not yet released their CoC Notice of Funding Availability (NOFO). HUD recommends that communities conduct their local competitions before the NOFO is released. The applications for our local competition are accessible via the online Zoom Grants platform, linked above. The application was not released via a Word or PDF document as it has been in years past, but you can click “print preview” in Zoom Grants to see the entirety of the application in one screen.

Should we submit two separate applications for new projects (ie, one for Rapid Re-Housing and a separate one for Permanent Supportive Housing)?

All new projects should be submitted in a single application. If a new project is applying for funding for multiple projects, they should check all project types that apply in question #7 of the application and provide a full description of all projects in question #12.

Once HUD releases the NOFO, if there are bonus projects you have not anticipated, how will you handle that?

If bonus funds are made available in the CoC NOFO, the Performance Evaluation Committee (PEC) will make decisions about bonus amounts based on the community priorities outlined by the Data and HMIS Oversight Committee and the strength of the individual applications. Agencies will be notified if PEC requires changes that need to be made to the funding amounts outlined in each project application.
