

Experience & Qualifications section, lacks resumes. In Capacity and Ability to Meet Scheduling Requirements section, may be too large of a company to get in touch with contacts, 30-45 turn around times. In Past Performance and References section, no dollar amount listed.

## Strengths

Experience & Qualifications section, very detailed overview of firm's years performing, listed resume of key individual. Capacity and Ability to Meet Scheduling Requirements section, smaller team, easier to get a hold of and work with. Past Performance and References section, worked with municipalities and has large contracts with others.

## Weaknesses

In Expereience and Qualifications section, brief summary no resumes of other key individuals. In Capacity and Ability to Meet Scheduling Requirements section, located out of state, office unknown. Past Performance and References section all located out of town.
