#### Strengths

In qualifications and experience section, listed Great experience. In Methodology section, great details. In demonstration section, working website, detailed just not what we buy or are looking for.

### Weaknesses

In qualifications and experience section, 2 out of the 3 projects don't apply (they are classroom and home libraries). Only 420,000 titles given, scope is different sizes than what we are looking for. In Methodology section, turnaround times were very vague, details listed as projects and not on going relationship for multiple years. In demonstration section, access only to public library not school level, some books were missing reviews, can't download to an Excel spreadsheet.

# Mackin Book Company dba Mackin Educational Resources Strengths

In qualifications and experience section, over 3 million titles listed, great experience, very detailed, similar scopes and on-going projects. In Methodology section, detailed, 8 step plans, detailed numbers such as their turnaround times and deliveries. In demonstration section, very specific, showed everything, website was great.

### Weaknesses

In the demonstration, did have 1 shipping error before.
