Any person or other entity considering an appeal should consult with an attorney to ensure that time and procedural requirements are met.”*

At all meetings, the commissioner chairing the proceedings shall have the authority to manage/limit the number of persons (non-Commission members) allowed to speak on an issue and to manage/limit such speakers' time.
