The Metropolitan Transit Ordinance known as "Choose How You Move", passed third reading at the Metropolitan Council on July 16, 2024, and was signed by Mayor O'Connell on July 19, 2024. The Transit Ordinance complies with the Tennessee Constitution, applicable state law including without limitation T.C.A. § 67-4-3201 et seq, and the Metropolitan Code.
