Strengths

Offer greatly fails to meet standards and demonstrates inferior understanding of solicitation goals & objectives.

Award justification notes significantly less strengths than weaknesses; weaknesses are impossible to correct.

Weaknesses

Proposal lacked substantive and detailed responses to the requested information on how the firm would specifically provide the the scope of work outlined in the solicitation. Evaluation criteria sections; qualifications and experience section did not include clear organizational structure and defined responsibilities of personnel. The performance and delivery and product availability and sourcing sections did not include definitive shipping, strategy, approach process details; responses were redundant or minimal to the requested information.

Award justification notes several major strengths; The firms proposal included detailed responses to all of the requested evaluation criteria sections; years of experience, references, approach, strategy, shipments, return policy, and sourcing information as authorized reseller of various products lines.
