Dizzy Donuts LLC dba DonutNV

Strengths

In Experience section, great food service experience. In Proposal section, defined in details the concept of their business. Good marketing plan. In Financials section, talked about using Quickbooks and Square when reporting on business and gave a 15% of income to Metro.

Weaknesses

In Experience section, runs with a food truck maybe a challenge to become a brick and mortar. In Proposal section, not detailed in inclusion/hiring plans. Limited menu, the least days/hours of a schedule of operating. If another event was scheduled that would have priority over the cafe. In Financials section, the percentage given jumped high from 1 year to the second, details were not given on how that was projected.

Making a Stand Society

Strengths

In Experience section, have a large number of locations for business and business model was great and detailed. In Proposal section, a large menu, schedule was Tuesday - Saturday. In Financials section, projections for 5 years given instead of 3 and monthly commission was great.

Weaknesses

In proposal section, details were limited in marketing for business, with the playground and families being the demographic for that park, concession food may not be the target for that group on a weekly basis. In Financials section, reporting for the business lacked details.

OLAS Flamingo LLC

Strengths

In Experience section, very well researched, great presentation of business plan and experience with other businesses. In Proposal section, great marketing plan, thoughtout process, menu is great, long hours of operations, approach was detailed and researched the area to see what the demographic would be and like. In Financials section, reporting was good, the monthly rent was great.

Weaknesses

In Experience section, has not done a business with the model the department is looking. In Proposal section, described a rent free time period. In Financials section, did not state how they came up with the numbers/projections.
