














3RD AVENUE CONSTRUCTION SEQUENCE

BEGIN CONSTRUCTION ALONG 3RD AVENUE AT PEYTON STAKES APARTMENTS:

- ERECT OSHA/ADA COMPLIANT SIDEWALK COVERING TO BE MOVED WITH WORK IN 160' SEGMENTS.
- PROVIDE OVERHEAD LIGHTING IN PROTECTION TUNNEL FOR PEDESTRIAN TRAFFIC.
- REMOVE/REPLACE SHEATHING AND SIDING ALONG BUILDING. PAINT BUILDING.
- MAXIMUM OF FIVE (5) PARKING SPACES TO BE CLOSED AT ANY GIVEN TIME ALONG 3RD AVENUE DURING CONSTRUCTION.
