Ms. Jane MacLeod, President/CEO of Cheekwood, thanked the Board for an opportunity to make a presentation. Ms. MacLeod then introduced Cheekwood's Board Chair Mr. Ronald Roberts to provide and progress update. Mr. Roberts thanked the Board, acknowledged the parking/traffic challenges and stated that they are working collaboratively will all stakeholders including the neighbors to try to find a solution to the problem. Mr. Roberts asked the Board for more patience for the completion of the Belle Meade Highlands Study.

Mr. Henley asked if there was a specific time frame that the Board is requested to consider.

Dr. Steele commented that the Metro Planning Commission estimated that the Belle Meade Highlands Study will be completed in November 2024 with recommendations of the report coming forth in January 2025.

Mr. Foster asked what immediate steps Cheekwood has taken as it relates to the safety concerns.

Ms. MacLeod commented that Cheekwood invests about \$250,000 annually in parking attendance/security/cameras. The area is constantly being monitored.

Dr. Steele commented that traffic is a major concern for residents. What has been done to address the traffic that is coming through the neighborhood.

Mr. Roberts and Ms. MacLeod commented that they implemented time ticketing during the pandemic to control the traffic and the amount of people who visit per day. Time ticketing is implemented 365 days a year, this generally moderates traffic so there is not backup.

Mr. Henley commented that as a Board we must take into consideration time for action and deliberation prior to the action of the completion of the study.

Dr. Stelle stated that this matter will be placed on the September agenda for discussion.

- Thank you all for your support as we celebrated Parks and Recreation month, last month. I hope that everyone will continue to enjoy our parks, greenways and facilities throughout the year.
- As of today, neighborhood Community Center hours have returned to school hours. Neighborhood center hours are from 12:00 8:30 p.m.
- The Cyber Senior Program graduation was held a couple of weeks ago at Elizabeth Community Center. This program is a computer literacy program in partnership with Nashville Public Library that partners Seniors and teenagers to learn about technology. This is a wonderful program and we we're happy to support.
- As you may recall, we received \$250,000 in this year's operating budget for additional community center programing at Napier Community Center. Our team is working to roll out the first piece of programing in October. We're also working to develop technology rooms at Coleman and McFerrin Community Centers thanks to the Digital Divide grants from the Titans Foundation. Once ribbon cutting dates have been confirmed, we will notify the board.
