4. Public Comment

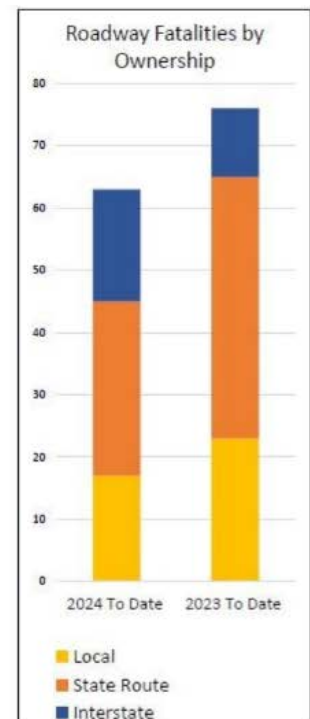

- Mr. Meleby presented on the fatal crash statistics for June. There were 11 fatal crashes for the month of July, 6 of which occurred on NDOT jurisdiction roads. There were 2 vehicle crashes, 3 pedestrian crashes and 1 motorcycle crash.
