



## APPEAL OF DECISIONS

If you are not satisfied with a decision of the Metropolitan Beer Permit Board regarding your application or your hearing, you may appeal the decision to the Davidson County Chancery or Circuit Court pursuant to the requirements set forth in T.C.A. 57-5-108. The decisions of the Metropolitan Beer Permit Board take effect on a date to be determined by the board. However, you may file an appeal within 60 days of the date of entry of the board’s decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.

## VIII. EXECUTIVE DIRECTOR'S REPORT

Executive Director Benton McDonough provided the Board with the revenue report. The Board inquired about the factors contributing to the increase in training fees. Inspector Brown informed the Board that approximately 20-30 individuals were attending training today, and the increase in fees is a combination of growing interest in training and failed compliance tests. When a location fails a compliance test, they receive a package that includes a letter from the Director along with training information. Inspector Brown noted that Douglas James manages the emails and schedules the training, which is conducted by Inspector Hardrick.

Douglas James further informed the Board that outreach efforts have been enhanced by sending training information to all new applicants at the start of the application process.

There was also a brief discussion about implementing a Responsible Vendor Program, similar to the one offered by the Tennessee Alcoholic Beverage Commission (TABC). Chairperson Taylor suggested that such a program could be a good revenue generator and serve as an additional safeguard for permittees who participate.

Chairperson Taylor also asked Inspector Brown if conducting compliance tests alongside the police department was affecting the Board's ability to inspect all permit holders countywide at least once per year. Inspector Brown responded that, due to staffing limitations, the Board has been able to inspect about 50-75%



of permit holders in recent years. However, he expressed confidence that with the current compliance testing model, the Board will be able to inspect over 75% of permit holders moving forward.
