Corporate Experience(20 Points)

Strengths: Firm's response addressed everything we requested in the RFP except for the weaknesses noted below.

<u>Weaknesses:</u> Q#1 - Firm did not adequately explain the specific reasons why their firm is the most qualified and best choice to be awarded this contract. Q#2 - Firm did not document meeting the minimum 5 years experience under its current business name providing the services requested in this RFP. Q#3 - Firm has low number of clients for Death Audit Services. Q#5 - Firm has a low number of clients for address search services.

Approach and Capacity (25 Points)

Strengths: Firm's response addressed everything we requested in the RFP except for the weaknesses noted below. Q#3 - Firm's response to identifying high probability deaths on a weekly basis. Q#13 - Firm's description / the system/solution and its capabilities you use to conduct address searches. Q#14 - Firm's system gives Metro an ad-hoc portal service for single searches, as well as the option to upload files via SFTP for batch address cleanups.

Weaknesses: Q#11 - Firm's response to what their success rate in identifying deaths and what is their accuracy rate.

Reporting and Security (25 Points)

Strengths: Firm's response addressed everything we requested in the RFP.

Weaknesses: No weaknesses were noted.

Corporate Experience(20 Points)

Strengths: Firm's response addressed everything we requested in the RFP except for the weaknesses noted below.

<u>Weaknesses:</u> Q#1 - Firm did not adequately explain the specific reasons why their firm is the most qualified and best choice to be awarded this contract. Q#3 - Firm did not respond to this question. Q#4 Firm did not provide a minimum of 5 city and/or county clients that they provide death audit searches that are of similar size to Metro's pensioner, spouse and child dependents population. Q#5 - Firm has low number of clients for address search services.

Approach and Capacity (25 Points)

Strengths: Firm's response addressed everything we requested in the RFP except for the weaknesses noted below.

<u>Weaknesses:</u> Q#2 - Firms response states using Limited Access Death Master File (LADMF)" to conduct a death audit search. Q#3 - Firm's decedent database is updated frequently with high probability deaths dependent on the source and with the state database on a monthly basis from certain states. Q#5 - Firm did not provide specific answer to this question.

Reporting and Security (25 Points)

Strengths: Firm's response addressed everything we requested in the RFP except for the weaknesses noted below.

<u>Weaknesses:</u> Q#1 - Firm does not have a website available to the employer. Q#2 - Firm does not have a website available to the employer. Q#4 - Date encryption and retention appears to be a negotiated term.

Corporate Experience(20 Points)

<u>Strengths:</u> Firm's response addressed everything we requested in the RFP except for the weaknesses noted below. Q#5 - Firm's table with the number of clients you provide address search services and provide commentary on the year-to-year changes.

<u>Weaknesses:</u> Q#1 - Firm did not adequately explain the specific reasons why their firm is the most qualified and best choice to be awarded this contract. Q#2 - Firm did not answer this question. Q#3 - Firm did not provide number of clients for Death Audit Services. Q#4 Firm did not provide a minimum of 5 city and/or county clients that you provide death audit searches that are of similar size to Metro's pensioner, spouse and child dependents population.

Approach and Capacity (25 Points)

Strengths: Firm's response addressed everything we requested in the RFP except for the weaknesses noted below.

Weaknesses: Q#2 - Firm's response providing a minimal list of sources you utilize to conduct a death audit search. Q#3 - Failed to confirm they can identify high probability death on a weekly basis. Q#4 - Firm did not adequately describe the system/solution and its capabilities you use to conduct death audit searches. Q#5 - Firm did not provide specific answer to this question. Q#6 - Firm's description on how they rank potential sources for the purposes of death validations. Q#8 - Firm does not provide Metro with the validated results. Q#10 - Firm states current obituary database is not comprehensive and uses two other data sets but did not verify alternative sources. Q#12 - Firm does not offer a preliminary mortality analysis to gauge what deaths might be currently overlooked. Q#13 - Firm did not adequately describe the system/solution and its capabilities they use to conduct address searches. Q#15 Firm did not provide what data do they require from Metro to conduct address searches? Q#17 - Firm confirmed address verifications is not a primary function of their company's services.

Reporting and Security (25 Points)

Strengths: Firm's response addressed everything we requested in the RFP except for the weaknesses noted below.

Weaknesses: Q#7 - Firm's response to what formats are available to export the reporting results to Metro.

Corporate Experience(20 Points)

<u>Strengths:</u> Firm's response addressed everything we requested in the RFP except for the weaknesses noted below. Q#1 - Firm's specific reasons why their firm is the most qualified and best choice to be awarded this contract. Q#2 - Firm exceeded meeting the minimum five (5) years of experience under its current business name providing the services requested in this RFP.

<u>Weaknesses:</u> Q#4 - Firm did not provide a minimum of 5 city and/or county clients that you provide death audit searches that are of similar size to Metro's pensioner, spouse and child dependents population.

Approach and Capacity (25 Points)

Strengths: Firm's response addressed everything we requested in the RFP. Q#13 - Firm's description of the system/solution and its capabilities you use to conduct address searches.

Weaknesses: No weaknesses were noted.

Reporting and Security (25 Points)

Strengths: Firm's response addressed everything we requested in the RFP. Q#3 - Firm confirms website does require multi-factor authentication (MFA) and also offers SSO at no additional cost.

Weaknesses: No weaknesses were noted.
