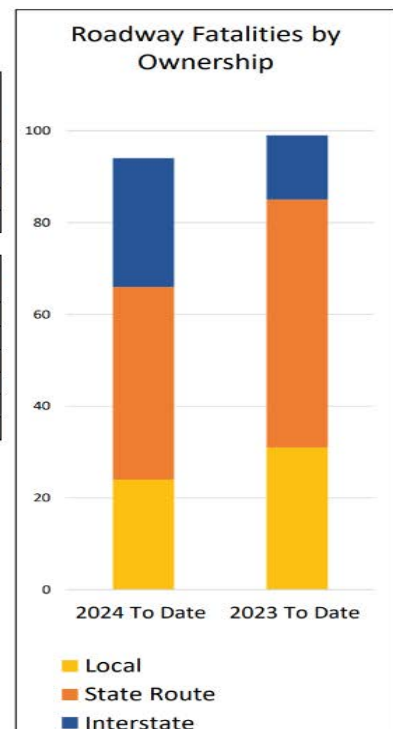
- There was no public comment at this time

5. Fatal Crash Statistics Update

- Mr. Meleby presented on the fatal crash statistics for September. There were 17 fatal crashes for the month of September, 11 of which occurred on NDOT jurisdiction roads. There were 3 vehicle crashes, 2 pedestrian crashes, 2 motorcycle crash, and 5 single vehicle crashes.
- Mr. Meleby went over the risk factor finding for each of the fatal crash site locations
