ANNUAL LOBBYING AND EXPENSE REPORT

Chapter 2.196 of the Metropolitan Code was amended in 2024. The amended language made changes to certain provisions of the Metropolitan Lobbyist Chapter of the Metropolitan Code, including those relating to the annual reporting of lobbying activities by a registered lobbyist.

PLEASE NOTE that as amended, the Metropolitan Lobbying Chapter requires every registered lobbyist to electronically file a sworn report regarding lobbying activities, expenses, and political contributions no later than January 31st for the previous calendar year. A person filing a report later than January 31st must pay a \$50 late filing fee. On March 1, lobbyists who have failed to file the sworn report or pay an applicable late fee will be ineligible for registration as a lobbyist for the current year. Any existing registration will be revoked and refunded until the lobbyist completes the report and the Board of Ethical Conduct has permitted the Lobbyist's registration pursuant to Section 2.196.110.B of the Metropolitan Code of Laws.

This report incorporates by reference all attached Schedules - A through F. Each report shall include a sworn statement from the lobbyist attesting to the accuracy of the reported information. Schedules A, B, and C report the lobbying activities and expenditures on behalf of a client. Schedules D, E, and F report the lobbyist's own lobbying activities and expenditures.
