#### **Public Comments**

Ms. Martha Lupai of A & M Marketplace discussed her current lease and past due payments. Ms. Lupai discussed a meeting that occurred with Executive Director Darrell Lane and Finance Manager David Griffin at the beginning of October. In the meeting and after a discussion about her past due payments she was presented a re-payment option. Ms. Lupai now does not understand why she has received a notice of default when she was given a repayment plan option by the NFM management team. It was explained to Ms. Lupai that the board of commissioners rejected the proposed re-payment plan as presented in the September meeting since it violated the terms of the executed lease agreement.

## **Grow Local Kitchen/Commissary Kitchen Update**

- ➤ Program Manager Heather Hoch and Marketing Manager Courtney Cotton discussed the rebranding of the Grow Local Kitchen and Grow Local Commissary. The re-brand will include a new marketing campaign of both kitchens, website redesign, enhanced business to business outreach, and removing Grow Local from the names. The new names will be the Kitchens @ the Nashville Farmers' Market with the two kitchen options being known as the Pop-Up Kitchen and Commissary Kitchen.
  - Board Member Moskovitz discussed price and that we should look at lowering the price if needed to generate additional business.
  - O Board Member Tarquino asked about a launch event for the Commissary Kitchen and what has occurred up to this point in an attempt to drive businesses to rent the facility.
  - Board Chair Radford wants to ensure the market is looking at the kitchen's utilization rate for a measure of success.
  - Board Vice-Chair Crane-Jones would like a KPI report of kitchen metrics presented to the board at the next meeting.
