Additionally, the Parks Department will retain the authority to remove the mural if it is deemed necessary in the future. This measure ensures that the artwork aligns with park standards and community expectations while maintaining the flexibility to address any concerns that may arise. The grant will fund up to 80% of the construction costs. The grant will fund up to 80% of the project cost which is estimated to be \$18,316,311.11. Greenways intends to apply for 70% of the estimated project cost in the amount of \$12,821,417.78 with Metro providing a 30% match of \$5,494,893.33. Council District 15.

Ms. Scott-Barnes commented regarding the difference in dollar amounts that were read by Dr. Steele than what is listed in their packets. Dr. Steele informed the Board that she received updated information. Ms. Cindy Harrison, Assistant Director of Greenways and Open Spaces was called to the podium to explain the difference. Ms. Harrison explained that as working through the budget sheet there was a couple of pieces of information that were not available to them at that time. They were able to include additional grant funding from construction administration and mobilization cost, causing the increase in funding.
