**25. Proposed Amendment to [Rule 13.4](#) (Kupin)**

Proposed amendment to Rule 13.4 of the Rules of Procedure of the Council.

13.4 No ordinance, ~~binding~~-resolution, amendment or substitute submitted after these prescribed deadlines will be considered by the Council except on an emergency basis. ~~Nonbinding resolutions submitted after the prescribed deadlines are not eligible to be considered on an emergency basis.~~ It is not the responsibility of the Council Office to prepare late-filed legislation.

**26. Proposed Amendment to [Rule 50.2](#) (Kupin)**

Proposed amendment to Rule 50.2 of the Rules of Procedure of the Council.

2. Those persons nominated shall be referred to the Rules Committee for recommendation. The Committee shall meet and determine the relative qualifications of the various candidates at two consecutive Committee meetings. Candidates shall appear for an interview at the first of the scheduled Committee meetings. A candidate may appear for an interview at the second of the scheduled Committee meetings upon approval of a motion of a member of the Committee at the first Committee meeting. Following the second Committee meeting, the Committee shall and report to the Council its recommendation at the next regular Council meeting ~~at least two weeks following the Rules Committee meeting wherein the candidates were considered.~~ No action may be taken upon such nominee until and unless such completed questionnaires have been sent to the Clerk by noon and Council members by 4:00 p.m. five days preceding the first Committee consideration of a nominee appearance before the Rules Committee. Any nominee who does not submit their questionnaire in time to meet this deadline shall be deemed to have withdrawn their name for nomination.
