# OHS Remains Committed to Data-Driven Solutions and Unsheltered Strategy




The Metropolitan Office of Homeless Services (OHS) is dedicated to implementing effective and efficient strategies to address homelessness in our community. As we approach the hot summer months, we are reminded of the critical importance of our unsheltered strategy. In the past two weeks alone, OHS and our community partners have provided cooling relief support to unsheltered individuals on nine occasions. This year's approach allows us to reach and engage with a larger number of people compared to operating a centralized shelter, which historically sees low utilization during warm months. These efforts are truly lifesaving, but we remain steadfast in our push for housingfocused outreach initiatives.

In light of the recent Supreme Court ruling in the City of Grants Pass vs. Johnson case, OHS will further align our efforts with the United States Interagency Council on Homelessness' 19 Strategies for Communities to Effectively Address Encampments. Our proactive community strategy prioritizes the needs of individuals, enabling us to be responsive rather than simply reactionary. This approach, in line with national best practices, has proven successful in providing temporary or permanent housing and shelter options as we transition the identified encampment community.

To address the Supreme Court's ruling, OHS will adopt a solutions-based approach. This includes hosting monthly open house/roundtable discussions, continuing to operate in a trauma-informed and compassionate manner, seeking ways to reduce harm in collaboration with community leaders, advocating for increased dedicated funding, and identifying housing solutions.

Housing, along with supportive services, is not just a solution but a necessity in ending unsheltered chronic homelessness. OHS has actively engaged with landlords, resulting in an expanded number of available housing options for unhoused individuals, surpassing our available rental subsidies. Additionally, we are excited to announce the Grand Opening Ribbon-Cutting Ceremony for Strobel House, Metro's first permanent supportive housing. This state-of-the-art, five-story, 90-unit riverfront studio apartment complex will provide much-needed housing for those experiencing homelessness.

While our data shows that we are performing better than the national average in many areas, we acknowledge that there is still much work to be done. Lives depend on our continued efforts, and we value the involvement of our community in our mission. There are numerous ways to get involved, from volunteering to actively participating in our continuum's committees, providing peer support, and dedicating housing units to our Landlord Engagement Team. **-April Calvin, Director**



New Landlord members may receive the following sign-on bonus amounts...

Shared Living: \$1000	2 Bedroom: \$3000
Studio: \$1500	3 Bedroom: \$3500
1 Bedroom: \$2500	4 Bedroom: \$4000

New Member Sign-On Bonus amounts are limited to the first 5 units leased-up to a tenant exiting homelessness.

Existing Landlord members receive an ongoing \$1000 sign-on bonus per lease up.

Landlords may receive up to \$2500 per unit for minor repairs to make a unit move-in ready (maximum of 5 units).

#### Application fees & Security Deposits

Landlords may receive up to \$500 per household to cover application fees and security deposits.

### **Furniture Allowance**

Clients may be eligible to receive a onetime furniture allowance of up to \$1500 via our local furniture vendor partnership.

### **Continuum of Care Program Funding Competition**

### Youth Homelessness Demonstration Program

The Youth Homelessness Demonstration Program is a HUD funding opportunity for Continua of Care to develop and execute a coordinated community approach to preventing and ending youth homelessness. Nashville was awarded a YHDP grant in 2017, currently implemented by the Oasis Center. 


# Welcome New Partnering Agencies
