Notice:

* **Insurance requirement:** “It is the responsibility of permitted event organizers to provide adequate liability insurance for the event.” The policy must be in force for the duration of the event. The policy must specify public liability and property damage insurance with a single limit of not less than one million dollars (\$1,000,000), naming the **Metropolitan Government of Nashville and Davidson County, 2565 Park Plaza, Nashville, TN 37203, as additionally insured.** No permit will be issued unless this certificate has been received. The Metro Department of Insurance may require additional coverage based on the scope of the event. **In addition to established fees, the Parks & Recreation Department will be reimbursed for all services directly related to the operation of any program or event if these services must be performed after normal operating hours and result in overtime labor costs.** The Parks & Recreation Department reserves the right to require that certain services must be performed by Parks personnel only
